

6. CONCLUSIONES

- 6.1. En el experimento se pudo observar que las distintas variedades presentan respuestas con diferencias altamente significativas, en lo que hace relación a longitud de tallo, número de entrenudos, peso fresco al final del experimento y pudrición total.
- 6.2. Entre variedades no se presentaron diferencias significativas para el número de brotes.
- 6.3. Los diferentes tratamientos utilizados presentaron respuestas altamente significativas con respecto a número de entrenudos y producción total.
- 6.4. No se presentaron diferencias significativas debidas a los tratamientos en lo que hace relación a la longitud de los tallos, número de brotes y peso fresco al final de la cosecha.
- 6.5. Los picos de producción se presentaron con anticipación cuando las plantas fueron iluminadas.
